

Splash Club Scholarship Policy

The team may, from time to time, elect to grant scholarships to current and prospective swimmers by waiving portions of the fees associated with the team and/or team trips. All requests and awarding of scholarships shall be reviewed and decided by Splash Club's Executive Board. The Executive Board will consider: the parent or guardian's financial condition, ability to pay, the USDA National School Lunch Program's reduced price meals income eligibility guidelines for the current year (Table 1.0), and other pertinent factors that may be brought to the Executive Board's attention. All scholarships shall be subject to the following:

1. A scholarship application must be submitted for the current swim season to be considered for a scholarship award.
2. Scholarships shall be granted for not more than one swimming year at a time (September through August).
3. Notwithstanding the foregoing, any scholarship may be terminated at any time upon notice to the swimmer and family.
4. Scholarships may be granted for any training group (with the exception of the Splashers lessons program).
5. Each scholarship recipient shall be expected to pay a portion of their Coaching Fees unless the Executive Board considers the case to be of extreme financial hardship.
6. Volunteer commitments must be met.
7. The Swimmer must earn and maintain good grades.
8. The Swimmer and Parent/Guardian must abide by all applicable Codes of Conduct, which includes but is not limited to USA Swimming's Codes of Conduct and Safe Sport policies and Splash Club Codes of Conduct.

whether the Swimmer is participating in that particular meet) and will fulfill the member's
volunteer hours commitment for each season.
- d. The Swimmer will earn and maintain good grades.
- e. The Swimmer and Parent/Guardian will abide by all applicable Codes of Conduct, which
includes but is not limited to USA Swimming's Codes of Conduct and Safe Sport policies
and Splash Club Codes of Conduct.
